- **3.1** Update on resumption of in-person services Statistics on services were provided for the months of April 2021 and April 2020. In April 2021 we had 334 in-person visits, of which 50 were appointments. We assisted 123 phone callers and had 76 email exchanges of information. In April 2020 we had 0 in-person visits, 109 phone calls, and 155 emails.
- **3.2** Scrabble Virtual Challenge update Twenty-nine participants have registered for the Scrabble Tournament. Ten in the competitive division and nineteen in the recreational division.
