

- **3.1** May & June Service Statistics Statistics on services were provided for the months of May 2022, May 2023, June 2022 and June 2023.
  - In May 2022 we had 429 in-person visits. We assisted 178 phone callers and had 78 email exchanges of information. In May 2023 we had 565 in-person visits, assisted 164 phone callers, and had 66 email exchanges of information.
  - In June 2022 we had 444 in-person visits. We assisted 165 phone callers and had 55 exchanges of information. In June 2023 we had 472 in-person visits, assisted 129 phone callers and had 85 email exchanges of information.
- **3.2** Librarian's Report: County Law Libraries did not receive any funding in the State Budget for the 2023-2024 Fiscal Year. In the past we have received amount varying from \$77,000 to \$93,000. This will have a huge impact to our budget requiring us to cut 45% of our resource budget. There was discussion around possible fundraising efforts and reaching out to our representatives. The discussion will continue at the next Board meeting in August.

- **3.1** July Service Statistics Statistics on services were provided for July 2022 and July 2023.
  - The librarian noted that the statistics in the agenda packet were incorrect. An error in the spreadsheet was found. The statistics for the previous year will be reviewed and corrected if in error.
  - In July 2022 we had 484 in-person visits, assisted 183 phone callers and had 58 email exchanges of information. In July 2023 we had 547 in-person visits, assisted 177 phone callers, and had 74 email exchanges of information.
- **3.2** Librarian's Report: County Law Libraries will be receiving money from the State intended to help offset revenue loss from the significant increase in income limits for fee waiver eligibility. We will be receiving approximately \$9,320. The money is expected to be distributed this month.
  - **3.2..1** Letter to Legislators included in the packet is a letter sent out by Trustee John Gallagher to our representatives.
  - **3.2..2** Fundraising included in the packet is a report from Trustee Emily DuBois on a request to members of the Santa Cruz County Bar Association for support. There was discussion about the request and other possible fundraising efforts.
